Ohio Governor DeWine declared a state of emergency due to the COVID pandemic on March 9, 2020 in Executive Order 2020-01D.

In an order issued on March 27, 2020, Ohio Supreme Court Chief Justice Maureen O'Connor advise the state's judges that all-time limitations and deadlines in court rules concerning filings, appeals and other matters are suspended through July 30, 2020 or the expiration of the health emergency.

Akron Municipal Court issued AMC Journal #4392 dated March 16, 2020 and AMC Journal # 4396 dated March 31, 2020 in response to the COVID pandemic. In an effort to minimize exposure to COVID within the court and the community we serve, and with the consent of the City of Akron Chief Prosecutor the Court is modifying waiverable offenses.

Based on these Findings of Fact, the Court issues the following Order:

- 1) Previous order 2020 MI 4392, 2020 MI 4394 and 2020 MI 4396 are hereby incorporated by reference into this Administrative Order and are further supplemented as follows;
- 2) The following offenses are waiverable until May 30, 2020 or the expiration of the health emergency:
