

# A word from Administrative/Presiding Judge John E. Holcomb

The Akron Municipal Court serves the residents of Akron, Fairlawn, Bath, Richfield, Springfield, Lakemore, and the Summit County portion of Mogadore. A total of 54,291 new cases were filed in 2007. The total number of criminal cases filed was 16,084. The total number of new civil cases filed was 15,411. The total number of new traffic cases filed was 22,796.

I want to take a moment and talk about four days in July and the impact they had on the court and on our community. After over a year of planning by the US Marshall Peter Elliot, local law enforcement, local churches, our own court administration, and others, Operation Fugitive Safe Surrender was launched on July 11, 2007. I would like to thank Bishop Johnson and his staff at The House of the Lord which allowed fugitives in our community to voluntarily and peacefully surrender. By the evening of Saturday, July 14, 2007, over 1,125 people had peacefully surrendered at the church. Court staff worked late into the night that Saturday to process as many of those defendants as they could. Those they could not process that night, came to court later. The bond that was


formed between the judges of the court, local community and church leaders and local law enforcement officers has lasted well past the program itself. It was one of the most incredible experiences that I have seen in my 13 years as a judge. Later in the annual report you will be able to see some of the images from this event.

Also in 2007 the court launched the DART program that focused on DUI offenders. The DUI Court models itself on the drug court model. This specialized docket is presided over by Judge Alison McCarty and was made possible by a grant from the Ohio Department of Highway Safety and with the assistance of the Ohio Supreme Court. The DART program is one of many tools available to the judges of the court to deal with alcohol and drug addicted offenders.

Some of the other programs that our court runs include the Drug Court, Family Violence Court, and the Mental Health Court. The court also runs a Mediation Program, a Discretionary Rehabilitation Program (DRP), and a License Intervention Program. The Akron Municipal Court runs more programs, with fewer staff, than any other court in the state of Ohio.

Finally I would like to thank all of the other Judges for their work this past year. They are Judge Callahan, Judge Michael, Judge Williams, Judge Belfance and Judge McCarty.

# The Judges

The Court's six judges are attorneys and are required by Ohio law to have practiced law at least six years prior to becoming a judge. The judges are elected on a nonpartisan basis and serve six-year terms. Their role is to supervise the administration of justice in their respective courts and insure that all trials, court hearings, and administrative procedures are fair and just.

# **History of Court**

In 1910 the legislature established a police court in Akron vested with jurisdiction over offenses under the ordinances of the city and all misdemeanors committed within the limits of Summit County. It was made a court of record and was presided over by an attorney duly admitted to practice in this state.


In 1919 the legislature established the Akron Municipal Court with three sitting judges elected for four-year terms. In 1930 two judgeships were added to the court. In 1939 the legislature reduced the number of judges from five to four. A fifth judge was again made a member of the court in 1967 and the sixth judgeship was created in 1975. The judges now serve six-year terms.

The court now serves a jurisdiction which includes the cities of Akron and Fairlawn; the townships of Bath, Richfield, and Springfield; the villages of Lakemore and Richfield; and that part of Mogadore in Summit County.

In 1966 the court moved into the City-County Safety Building which was renamed the Harold K. Stubbs Justice Center in 1991 located in downtown Akron. The sitting judges are Judge John E. Holcomb, Lynne S. Callahan, Eve V. Belfance, Alison McCarty, Kathryn Michael, and Annalisa S. Williams.

# The Akron Municipal Court D.A.R.T. Program

"Discovering Abstinence through Responsibility and Treatment"

On May 13, 2007, the DART program became the 4th specialty court program to be implemented in the Akron Municipal



Court. The program targets individuals who have been arrested for a 2nd or 3rd OVI offense within a 6-year period along with individuals who have multiple OVI convictions in their past. The Akron DART program is one of three OVI Court pilot programs in Ohio and was awarded a three-year grant by the Ohio Department of Public Safety Governor's Highway Safety Office. The Akron DART program is a collaboration between the Akron Municipal Court, The Governor's Highway Safety Office, The



Supreme Court of Ohio Specialized Dockets, ODADIS, The Summit County ADM Board and subsidiary agencies: The Summit County Sheriff's Office, The Akron Prosecutor's Office, and Summit County Legal Defender's Office.

The goals of the DART program include: enhancing public safety, reducing jail overcrowding and recidivism along with encouraging program participants to obtain gainful employment, a valid driver's license and abstinence from drugs and alcohol. The DART program utilizes the principles and philosophies of the nationally recognized "Drug Court Model" which includes regular appearances before the judge, random drug and alcohol screens, successful completion of treatment programming, graduated sanctions and rewards and intensive supervision. In addition to having multiple OVI conviction, eligible participants must be resident of Summit County, express a desire to change drinking and driving behavior, have a non-vi-

olent criminal past and have the ability to get to-and-from required treatment programs and court appearances.

The DART program team includes Judge Alison McCarty, Tony Ingram, Jeff Sturmi, Jill Forster, Matt Esterle, and Andrew Rudgers all with the Akron Probation Department. The Akron DART program current serves 41 participants and has the capacity to serve as many as 75. For additional information or

# **Drug Court**

Judge John Holcomb is the Akron Municipal Drug Court Judge. The Akron Municipal Drug Court began in 1995 and is the longest running specialty court in Akron. Akron's Drug Court continues to serve as a model program for many Drug Courts across the state. It is a collaborative effort between the Akron Municipal Court, Akron Police Department, Akron City Prosecutor's Office,

Public Defender's Office, Akron Municipal Probation Department, Summit County Alcohol, Drug Abuse and Mental Health Board, and Oriana House, Inc.

The Drug Court philosophy promotes court-ordered, judicially supervised treatment. The participants are male and female offenders originally charged with felonies, either possession of cocaine or methamphetamine.

All prospective offenders are initially screened by the Oriana House admissions Department to determine eligibility. Police and prosecutors must also approve the offender for admission into the Drug Court program.

The program requires that the offender come to court and plead guilty to a reduced, misdemeanor charge of attempted drug abuse. A six-month jail sentence is then imposed, but suspended. During the course of the next year, the participant will undergo assessment and treatment. The level of

treatment is determined by the seriousness of the offender's addiction. At a minimum, each offender will meet with a caseworker at least once a week, must attend AA meetings and undergo frequent drug testing.

The program is based on a reward. Sanctions begin model: if a participant stays sober and performs well in the program, he or she will receive rewards. If the offender relapses with new drug use, or fails to comply with other aspects of the program, he or she will face graduated sanctions. Beginning with courtroom observation or a few days in jail, leading up to the final sanction for noncompliance, is termination from the program and six months in the Summit County Jail.

The Drug Court is a successful method of treatment for offenders, and a major component of its success is the close supervision and involvement of the judge.

# **Family Violence Court**

The family Violence Court was implemented in April of 1998, in response to the growing number of domestic violence cases. The need to provide a sanctioning option to reduce jail crowding, the desire to address both victim and offender needs, and the desire to enhance probation supervision and to protect the public safety.

Akron's Family Violence Court is a domestic violence

diversion program, the only one of its kind in Ohio, and one of very few throughout the country. The actual program is the combined brain-child of the Oriana House, Inc., the Akron Municipal Court and its probation

department, Akron's prosecutor's office and police department, the Summit County Prosecutor's Office, Victim Assistance, the Battered Women's Shelter, and the Public Defender's Office. The program provides

increased supervision of the offender as well as increased coordination of services. Judge Lynne S. Callahan presides over the Family Violence Court. Offenders who enter the Family Violence Court Program are required to complete a twenty-six week violence cessation program, case management, one year of probation, drug and alcohol testing and counseling if needed,

and employment counseling if needed. Victims are urged to attend the Early intervention Program and Stop the Cycle at the Battered Women's Shelter. They have access to a victim advocate through every step of the proceedings.



## **Mental Health Court**

The Akron Mental Health Court was the first of its kind in Ohio and remains one of a handful in the United States. The Mental Health Court was formed, in part, as a response to the overwhelming number of mentally ill offenders being seen by the Akron Municipal Court.

This program is a collaborative effort between the Summit County ADM Board, Community Support Services, and the Akron Municipal Court. Residential treatment is provided by Oriana House, Inc., Sharp Program. The program is envisioned as a diversion program with a significant jail reduction component in the short and long term. The model follows the drug court model with early intervention and stable release into the community with multi-year intensive probation and frequent court appearances. Prior to the Mental Health Court, mentally ill offenders who were not stable on medications, were waiting in jail for up to six weeks before a competency evaluation was completed. This diversion court reduces the time spent in jail to less than two weeks. One of the goals of the Mental Health Court is to end the cycling of the mentally ill offender through the local jail and the state hospital.







2007 Top Five Civil Case Filings


2007 Traffic Court Cases
